Springfield Insights

David Yepsen, Director of the Paul Simon Public Policy Institute, shared a broad range of insights to current matters in Springfield. He is a prominent journalist with notable perception of public policy, politics, and governmental affairs.

Opening with the statement that Illinois has "the worst economic status in the country," Yepsen added that changing that status will take years. Yepsen reported that the state economy is growing, but other states are already improving faster.

He opined that the new administration recognizes the need to get on the right path, but also that it will take months to years to see significant improvement. He commented also that the ethical climate in the state is a relevant factor in achieving economic improvement.

Specifically addressing the budget, he acknowledged the draconian changes, saying that the university and local government will feel the impact especially strongly. Commenting on "bashing of unions," Yepsen labeled it a game needed to satisfy the Republican base and caucuses facing potential (likely?) revenue increases. He predicted that Democrats will pass a counter-budget that leads to a gubernatorial veto and set up further negotiation.

Yepsen foresees proposals to broaden the sales tax base, to tax retirement benefits, and to reimpose the income tax levels that recently ended, finishing with "This is Illinois ... don't be surprised at anything."
